POSITION SUMMARY:

Keeps locker rooms and bathrooms clean and stocked. Roams the YMCA building insuring safety and cooperation with YMCA policies from members and Staff. Carries a radio to assist all departments when needed with facility issues.

ESSENTIAL FUNCTIONS:

- Completes all duties listed on the daily schedule and maintains upkeep of assigned area and
 equipment. Duties include, but are not limited to, clean and disinfect all touch points in locker
 rooms, toilets, sinks, mirrors, door handles, drinking fountains etc., includes wet and dust
 mopping, dusting, trash removal, recycling, window washing, cleaning fans in public areas,
 painting, vacuuming, seasonal activities to include lawn care and snow removal, and general
 cleaning.
- 2. Pick up used towels and stock towels throughout the facility. Assist with laundry operations as needed.
- 3. Operates related motorized and non-motorized equipment.
- 4. Records and reports all needed repairs; repairs as directed.
- 5. Ensures YMCA building and property is secure during shift and report incidents and hazardous conditions to supervisor.
- 6. Replaces soap, paper towels, toilet paper, hand sanitizer and other supplies.
- 7. May set up furniture for events.
- 8. Participate in staff meetings and/or related meetings.
- 9. Becomes familiar with YMCA safety program, including meetings, trainings and inspections. Becomes familiar with necessary program documentation for safe handling of cleaning products, PPE etc.
- 10. Familiarity with and ability to assist with insurance inspections, fire inspections, OSHA, county health requirements and universal building codes.
- 11. Represent and promote the YMCA in the community and community events as needed; develop positive working relationships with YMCA staff of all departments

- Always have a friendly, helpful attitude and wear a smile.
- Take initiative to greet and assist all members, potential members, program participants and volunteers in a courteous, professional and friendly manner. Be enthusiastic towards members by learning their names and expressing an interest in their YMCA activities.
- Work daily to develop personal and meaningful relationships with members, volunteers, donors and others. Strive to understand individual's goals and interests to enrich their YMCA experience by introducing them to new programs, staff, members and volunteer activities.

- Be knowledgeable and supportive of the YMCA annual support campaign.
- Be informed about volunteer opportunities.
- Speak enthusiastically on behalf of the YMCA publicly and at given opportunities.

TEAMWORK

- Ability to establish and maintain harmonious relationships with staff members in all departments.
- Seeks every opportunity to encourage, motivate and thank fellow staff members for their work. Completes S.T.A.R. slips to thank and recognize a job well done by others.
- Be knowledgeable about YMCA programs. This includes being familiar with all current program guide information, upcoming events and other special activities.
- Keeps up to date on all internal communication.

OPERATIONAL EFFECTIVENESS/SAFETY

- Be dressed in appropriate attire and wear nametag at all times. Consistently perform duties in a safe and conscientious manner.
- Follow and enforce all YMCA procedures and policies, including those related to: personnel guidelines, medical and disciplinary situations, child abuse prevention, safety guidelines, facility access procedures, membership policies and emergencies. Complete Incident Report Forms as required.
- Be knowledgeable of all current Emergency Action Plans and carry out plans as necessary.
- Maintain a clean and safe YMCA. Take initiative to clean up/repair areas. Complete Maintenance Request forms as needed. Report safety issues to the appropriate supervisor.
- Attend and remain current on all mandatory trainings and staff meetings.

OUALIFICATIONS:

- 1. Six months or more of related experience preferred.
- 2. Ability to read and interpret instructions, procedures, manuals, and other documents.
- 3. Ability to report and record maintenance requests.
- 4. Knowledge of cleaning methods and equipment.
- 5. Basic understanding of the upkeep and care of equipment.
- 6. Understanding of cleaning compounds and chemicals, and their safe, efficient use.
- 7. Ability to learn and manage minor facility systems as needed.
- 8. Ability to work evenings and weekends.

PHYSICAL DEMANDS:

- 2. Sufficient physical strength and agility to carry out essential duties.
- 3. Ability to work from ladders and platforms at heights.
- 4. Ability to work with paint, cleaning equipment, chemical compounds, solvents, cleaners, and solutions in dry, liquid, powder, spray, and aerosol forms.
- 5. Ability to paint, clean equipment, and operate motorized equipment as needed.
- 6. Ability to work in conditions that will create dirt and dust.
- 7. Ability to perform essential maintenance to facility or equipment which may involve, but not limited to the following activities: reaching overhead; crouching; kneeling; shoveling; carrying, working in narrow and/or confining spaces, overhead, and at ground level; twisting of the waist, shoulders, and legs.
