FAIRGROUNDS YMCA - THIS IS A MULTI FACETED PROGRAM CENTER WHICH INVOLVES OVER 2,300 MEMBERS IN FITNESS, 800 YOUTH IN GYMNASTICS, 150 YOUTH IN DANCE PROGRAMS AND THE LARGEST EMPHASIS IS ON LEAGUE SPORTS PLAY. SPORTS INVOLVES 140-150 TEAMS EACH 10 WEEK SESSION WITH OVER 1,500 PREDOMINANTLY YOUTH INVOLVED. SPORTS INCLUDE SOCCER, LACROSSE, BASKETBALL, FOOTBALL AND BASEBALL. THE EMPHASIS IN OUR LEAGUES IS ON SKILL DEVELOPMENT AND CHARACTER BUILDING. TEAMS ARE ALL COACHED BY VOLUNTEERS. FINANCIAL ASSISTANCE IS AVAILABLE FOR PROGRAMS AND MEMBERSHIPS TO ENSURE ACCESS FOR EVERYONE. PROGRAM ASSISTANCE ALONE IS VALUED AT OVER \$50,000 AND INVOLVED 284 CHILDREN IN 2012. SCHOOL AGE CHILD CARE IS DESIGNED TO PROVIDE A SAFE, CARING, AND FUN ENVIRONMENT BEFORE AND AFTER SCHOOL FOR CHILDREN OF WORKING PARENTS. THE PROGRAM IS OFFERED AT 18 SCHOOL SITES DURING THE YEAR AND 2 SCHOOL SITES DURING THE SUMMER FOR YOUTH IN GRADES KINDERGARTEN - 6. THE PROGRAM INVOLVES OVER 400 CHILDREN DAILY IN RECREATIONAL AND EDUCATIONAL PROGRAMMING. FINANCIAL ASSISTANCE IS AVAILABLE TO ENSURE EVERYONE CAN PARTICIPATE.
