Watertown Family YMCA Living Our Values

Code of Conduct

The Y is committed to providing a safe and welcoming environment for all members and guests. To promote safety and comfort for everyone, all individuals are asked to act appropriately while exhibiting the character values of respect, responsibility, caring and honesty. A member, program participant, or guest who is in violation of the Code of Conduct could be subject to consequences including removal from a program and/or termination of membership or program privileges.

RESPECT - Value the worth of every person, serve as an example

- Verbally abusive or vulgar language, including swearing, name-calling, shouting or threatening is not permitted
- All members serve as examples for the children and young people in our Y, demonstration of sexual activity or sexual contact with another person is not permitted
- Appropriate attire must be worn; please refrain from overly revealing attire
- Loitering is not permitted in or outside YMCA facilities or programs
- To protect the privacy of our members, cell phone use is not permitted in any locker room or rest room areas. Discreet and respectful use of cell phones is allowed in public/open areas only.

RESPONSIBILITY - Do what is right, be accountable for actions and behaviors

- For your safety and the safety of others posted rules in program areas must be followed
- You may not carry or conceal devices that may be used as weapons*
- Use or possession of illegal drugs or alcohol on YMCA property or at YMCA programs is prohibited.

CARING - Show sincere concern for others, be kind in words and actions

- Physical contact with another person in an angry or threatening way is not permitted.
- Harassment or intimidation by words, gestures, body language or menacing behavior is not permitted.
- Smoking, e-cigarette and tobacco use are not permitted. YMCA grounds and facilities are smoke, e-cigarette and tobacco free environments.

HONESTY - Demonstrate reliability and trustworthiness through action

- For your safety and security, members and guest pass users must check-in with their membership card/photo ID at the Welcome Desk and identify themselves when asked by YMCA staff.
- Theft or behavior that results in the destruction of property, will not be tolerated.

Anyone who feels that this Code of Conduct is being violated should report the behavior to a staff person on duty. YMCA staff members are eager to be of assistance. Please notify a staff member if assistance is needed.

Suspension or termination of YMCA membership or program privileges may result from a violation of this Code of Conduct. While an incident is being investigated, the membership/program participation of the person(s)

accused of violating this Code of Conduct may be temporarily suspended pending a final decision.

Our YMCAs utilize video technology to protect all persons. Cameras are installed in open/public areas only and not in private areas such as locker rooms, restrooms, etc.

Sexual Offender Background Check Policy:

The Watertown Family YMCA considers it of great importance to provide a safe and threat free environment. The YMCA utilizes a nation-wide screening software to identify individuals listed on the national sex offender registry. Persons identified on the national registry will not be eligible for YMCA membership or programs.

*Does not apply to Law Enforcement Officials carrying weapons within the bounds of their public duty

YOUTH - CODE OF CONDUCT

The Watertown Family Y is a youth-serving, community-based membership organization. The YMCA believes in the core values of honesty, caring, respect, and responsibility. Participation in Y programs is subject to the observance of these values for the safety and comfort of all.

The activities outlined in the following list are strictly prohibited:

- Verbally abusive or vulgar language, including swearing, name-calling, shouting or threatening
- Possession, use, or under the influence of alcoholic beverages or illegal drugs Y property
- Bringing onto YMCA property dangerous or unauthorized materials such as explosives, firearms, weapons, or other similar items
- Disrespect or rudeness
- Verbal, physical, visual harassment or intimidation towards others
- Actual or threatened violence toward any individual or group
- Conduct endangering the life, safety, health, or well-being of others
- Bullying or taking unfair advantage of anyone
- Failing to cooperate with Y staff
- Entering restricted areas of the Y.
- Opening doors to allow others unauthorized access to the facility. (All must enter and exit through the front door of the Y)
- PDA (Physical Displays of Affection) /Sexual Conduct
- Destroying Property/ Improper Use of Equipment
- Other behaviors in violation of posted Member Code of Conduct or Posted Specific Area Rules.

Any member, program participant or guest who violates this code is subject to discipline, up to and including removal from the program or termination of membership. Based the severity of the infraction, Membership or Guest access may be permanently terminated. The decision of the staff is final.

I have read and I understand the YMCA Code of Conduct and the YMCA Code of Conduct for Youth and Teens if applicable. I agree to abide by the rules described above and understand that I, my Family Members or others for whom I am acting as agent may be removed as a participant if I or they violate any of these rules.

Covid 19 Commitment

Program & Cancellation Policies

Program Registration and Cancellation Policies Watertown Family YMCA Registration Policies:

- Pre-registration is necessary to allow for class preparation and communication.
- Registrations are subject to class size/availability and are not guaranteed.
- Payment must be received at the time of registration. We are unable to reserve a space without payment.
- Waitlists: If you are on a program waitlist, you will be contacted (in chronological order) in the event any spots open in the program.
- Fees are due at the time of registration for the program.
- You must respond within 24 hours if/when you are invited to move off the waiting list and register, or you will lose your spot on the waitlist.

Cancellation Policies:

- Registration cancellations can be honored up to 48 hours prior to the start date of the program and will be issued as YMCA credit or can be posted back to original credit/debit card payment or refunded by check.
- Registration cancellations within 48 hours of the program start date or after the start date of the program through half of the program session will be refunded with YMCA credit for 50% of the program cost. Cancellations after more than half of the program sessions are not subject to refund or credit. (see NOTE)
- Monthly recurring programs with an EFT bank draft require 30-day notice for termination.
- The YMCA reserves the right to combine classes if there is insufficient enrollment or cancel classes if combining levels is not an option. In the event of a cancelled class, a full refund or YMCA credit will be given. YMCA credits are good for one year from the date of issue and may be used for any fee-based YMCA program.
- Make-up classes or refunds for classes missed due to personal conflicts are not permitted. Please check your schedule for possible conflicts before committing to a session.
- Make-up classes for swim lessons missed due to special circumstances may be available. Make-up swim lessons for those circumstances must be scheduled with the Aquatics Director and will be made-up subject to class availability.
- If a class or classes in a program are cancelled by the YMCA, a make-up class will be offered to ensure the total classes promised have been offered. In the case that we are unable to fulfill the total classes promised, you will receive a refund for the class(es) that were cancelled.

These policies will apply to all fee-based programs at the Downtown YMCA, Fairgrounds YMCA, Carthage YMCA and Sackets Harbor YMCA, unless stated otherwise in the program description and or informational/promotional materials. NOTE: We understand there may be special situations that need extra consideration, and we attempt to accommodate everyone fairly and evaluate these situations on a case-by-case basis.
