HEALTHY EATING AND PHYSICAL ACTIVITY AND AN ENRICHING, NUTURING AND AGE APPROPRIATE DEVELOPMENT AND EDUCATION ARE FOCUS AREAS FOR PROFESSIONAL CHILD DEVELOPMENT STAFF. ADDITIONALLY, THE DAYCARE PARTNERS WITH WATERTOWN CITY SCHOOL DISTRICT (WCSD) TO PROVIDE PRESCHOOL AND EDUCATION PROGRAMS TO 3 AND 4-YEAR-OLD YOUTH LIVING IN THE WCSD.
