A MESSAGE FROM OUR LEADERSHIP

Dear YMCA Family and Friends:

We are happy to share this annual report of results for the YMCA of South Palm Beach County and would like to thank the many dedicated volunteers, staff, Y members and donors who contributed in making 2020 a successful year.

Last year, the global and national spread of COVID-19 affected so many in our community, and our YMCA was not excluded. On March 17, 2020, the COVID-19 crisis forced us to make one of the toughest decisions in our Y's history, temporarily closing our branches and suspending most programs and services.

Despite uncertainty, our Y stepped up and adapted to the emerging needs of our neighbors. Together, we worked hard to keep our children, families and adults engaged, active and connected, while safely apart. As a community resource committed to being a leader in social responsibility, we responded by:

- Providing Relief Camp Care for children of health care and emergency service workers.
- Delivering Drowning Prevention virtual training during school closures to keep children Safe Around the Water.
- Offering Summer Camp at the Y and community locations with fun and educational child care for working families.
- Providing Financial Assistance to help support those in need of Y programs and resources.

We are also proud to share that throughout the pandemic our YMCA remained focused on the health, safety and well-being of our staff team.

Our YMCA spent weeks carefully considering how we could safely reopen our doors, following guidance from the CDC and health officials to update our policies and procedures ensuring the highest standards of cleanliness and care. After making special accommodations for social distancing and taking numerous other safety precautions, we were proud to reopen our doors on June 1, 2020.

We are so grateful to all those who stood by us throughout these challenging times and supported our YMCA. Due to the generosity of our donors, partners, members, staff and friends, our YMCA remains here for our community.

MEETING COMMUNITY NEEDS DURING COVID

During the 2020 COVID-19 pandemic, the YMCA of South Palm Beach County transitioned our services and facilities to meet vital needs in our community by providing affordable childcare for essential workers, building virtual health and education programs, and collaborating with partners to support emergency services.

EMERGENCY CHILDCARE

99 children of healthcare and emergency service workers participated in our Y's Camp Care for Essential Workers, which helped support parents in **18** essential industries.



OUTREACH

Virtual resources and information was emailed weekly to an estimated **4,300** members, donors, and partners during our facility closure.

1,538 calls and emails were made to our senior members to help combat

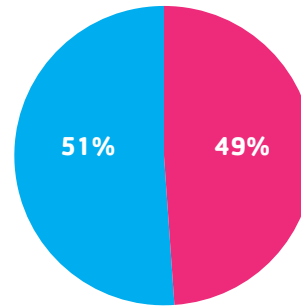

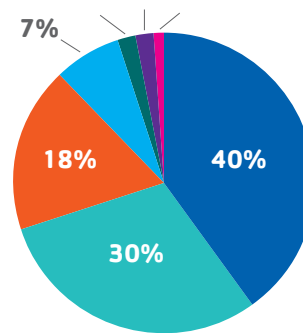
Change in Net Assets \$ (477)

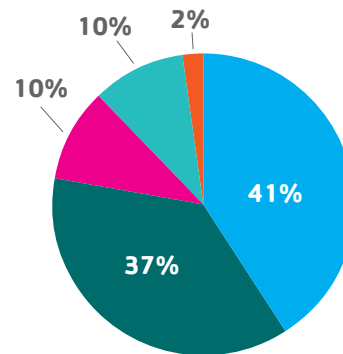
